## I. Board of Regents Meeting

Chairman Jack C. Morgan reminds you of Regents on Wednesday, December 13, at 2:00 P.M., on the college campus. This will be a work session meeting to tion of the Legislative Budget Board.

The Chairman also reminds Board Members that other items may be discussed at the discretion of Committee Chairmen and other individual members of the Board.

#### II. Board Committees

#### A. Academic and Personnel Committee

Personnel Committee Meeting - At a meeting of the Academic and Personnel Committee in Regent Dean W. Turner's office in Henderson on December 7 at 3:00 P.M., the committee approved the employment of eight personnel in accordance with the attached report.

Also, the committee heard an information report concerning Tyler State College's status with the Southern Association of Colleges and Schools and considered further the subjects of Group Hospitalization and Life Insurance Programs and the selection of additional Optional Retirement Program carriers for the institution.

2. Coordinating Board - The Coordinating Board, Texas College and University System, will consider the complete programs at Tyler State College at the next meeting which will be conducted on Saturday, January 20, 1973. Courses which will be taught during the 1973 Spring Semester at Tyler State College have been approved by the Coordinating Board Staff.

#### B. Campus and Building Committee

1. <u>CRS Presentation</u> - Enclosed is a copy of the CRS presentation to the Board of Regents in the meeting on November 29, 1972, along with an additional copy of the document "Goals for Tyler State College Project".

2. Work Session with CRS Representatives - Bill Steely, Willie Pena, and Reinhard Schneider were on the campus for a meeting on December 6. Technical data relative to academic space planning was the primary area of consideration during this meeting. Documentation of the meeting will be made available within a few days.

State Approval for Veterans Education Attached is the Approval Notice from the Texas Education Agency stating that Tyler State College is approved for the training of veterans and dependents of veterans. Under this program a veteran with no dependents enrolled as a full time student will receive \$220 per month in educational benefits. These benefits increase with the number of dependents.
