Death Penalty vs. Life in Prison: A Cost Analysis

Abstract

This project assesses the differences, cost wise, of sentencing someone to life in prison without parole versus the death penalty. 

For Florida, DP costs consist of sustaining them on death row and the DP itself. On average, it costs \$25,000 per year to support an inmate on death row. Florida spends about \$51 million for the option of the DP. Time and money accompany appeals, post-appeal motions, and supplementary appeals. One of the largest costs is for collateral attorneys, who represent inmates. Costs of sentencing a prisoner to life in prison involve the annual costs of sustaining them in prison plus Geriatric care, and other court costs.
