
# **Dr. Hewett New Business Dean**

Dr. Wendell C. Hewett, a fiveyear faculty member with The University of Texas at Tyler, is the new dean for the School of Business Administration. He succeeds Dr. George Joyce, who asked to be reassigned to a fulltime teaching capacity.

The new dean holds the B.B.A., M.B.A. and D.B.A. degrees from Texas Tech University. He has 18 years teaching experience, including positions at Northeast Louisiana University, Texas Tech and the University of Alabama before joining UT Tyler in 1976.

Dr. Hewett, who is a professor of business administration, was promoted to chairman of the Department of Management and Marketing in 1978.

The announcement of Dr. Hewett as the new dean followed a nationwide search to fill the position. "It is a pleasure to announce the selection of Dr. Hewett to this very important administrative and teaching position within the university," Dr. George F. Hamm, president, said. "It is encouraging that an individual of his caliber is already on the faculty at UT

# Dr. Smyrl Reassigned; Interim Dean Appointed

Dr. Frank H. Smyrl has submitted his resignation as dean of the School of Liberal Arts and asked to be reassigned to a fulltime position as professor of history, effective at the beinning of the fall semester.

The resignation and the appointment of an interim dean for the 1981-82 academic year were announced by Dr. Donald W. Whisenhunt, vice president for academic affairs.

Dr. F. Lannom Smith is serving as interim dean while a search is underway for a permanent replacement. Smith, a professor of English, has been serving as chairman of the Department of Humanities and Communications. His replacement as interim chairman of the department is Dr. Janice Glascock, professor of Spanish.

Dr. Smyrl joined the UT Tyler faculty in 1973 and one year later was appointed dean. He is a past president of the East Texas Historical Association and the Smith County Historical Society. He holds the B.A. and M.A. degree in history from The University of Texas at Austin and the Ph.D. from the University of Oklahoma.

Dr. Smith joined the faculty in 1973. He holds the B.A. degree from Emory University, the M.A. from the University of North Carolina and the Ph.D. from the University of Pennsylvania. Dr. Glascock, a UT Tyler faculty member since 1975, earned the B.S., M.A. and Ph.D. degrees at Louisiana State University. Tyler. We look for outstanding leadership from him in the continued growth of the School of Business Administration."

Dr. Hewett also announced the promotion of two faculty members to chairman of departments. Dr. Marilyn Young was selected as chairman for the Department of Management and Marketing and Dr. James H. Sellers is the new chairman of the Department of Accounting.

The departmental vacancies occurred with the promotion of Dr. Hewett and the resignation of Dr. Milton Jones, who joined the faculty at Baylor University.

Dr. Young, an associate professor of business administration, holds the B.S.B.A., M.B.A. and Ph.D. degrees from the University of Arkansas. She has been a member of the UT Tyler faculty since 1974, having previously taught at Arkansas and Southeastern Louisiana University.

Dr. Sellers also holds the Ph.D. from the University of Arkansas. He earned the B.B.A. degree from The University of Texas at Austin and the M.B.A. from the University of Houston. He joined the UT Tyler faculty in 1978 as professor of accounting. His 15 years teaching experience include positions at Arkansas, Texas A&M University and the University of Mississippi.



# Library Given Medical Book Collection

# Books of Long-time Tyler Doctor Received

A collection of medical books of the late Dr. Hascall Muntz has been contributed to the library of The University of Texas at Tyler by his wife.

The collection of several hundred — plus office equipment and a copy machine — represents the largest single gift to the library since it was opened. Value of the books is more than \$9,000 and the total gifts exceed \$11,000.

"Hascall liked knowledge. He taught chemistry in college and taught nurses in medical school. It will be meaningful to know that his medical books and journals will continue to serve a useful purpose," Mrs. Muntz said in presenting the collection to Mrs. Olene Harned, university librarian.

Dr. Muntz practiced medicine in Tyler from 1948 until his death in January 1981. The Vienna, Austria native came to the United States with his family when he was six months old. They settled in Toledo, Ohio. He received his B.S. degree from the University of Toledo and his medical degree from Indiana University School of Medicine.

He served on the staffs of Indiana University Medical Center Hospital, Mother Frances and Medical Center Hospitals in Tyler. He also served two years in the Medical Corps in the U.S. Army.

Dr. Muntz was a member of the American Medical Association, associate member of the American College of Physicians, American Diabetes Association, American Heart Association, American Trudeau Society, Smith County Medical Society, Inc., American Geriatrics Society, the Royal Society of Health, American Society of Internal Medicine, Texas Medical Association, Texas Society of Internal Medicine and Texas Diabetes Association.

Dr. Muntz published several articles in medical journals, in-

cluding one on mumps vaccine, method of mixing insulins and one on Rocky Mountain spotted fever. He was president of the East Texas Symphony in 1957 and

belonged to Temple Beth El. Mrs. Evelyn Muntz, a Kilgore native, continues to live in Tyler with their youngest son, William, a student at Moore Middle School. Other children include: David Muntz, a resident of Dallas and a director of the computer department at Wadley Institute in Dallas; Dr. James Muntz, who is in the private practice of internal medicine in Houston; Mrs. Julie Johnson of Houston, a teacher in a Houston high school; and Miss Ellen Muntz of Austin, an account executive for the Austin American Statesman.

Mrs. Muntz, who holds the B.A. and M.L.A. degrees from The University of Texas at Austin, has taken many courses at UT Tyler and considers the library one of the many assets of the university.
