Subject: Administrative Notes

I. 1974 Fall Semester Enrollment

The official twelfth class day enrollment for the Fall Semester 1974 is 864. This represents a 70.4 percent increase over our enrollment one year ago.

II. Southern Association of Colleges and Schools Accreditation Visit

We were very fortunate to have had such an excellent Southern Association of Colleges and Schools Visitation Committee on our campus last week. Although it is premature to attempt a discussion of the visit in detail, it is appropriate to relate that the committee was generally favorably impressed with our efforts at Tyler State College. Certainly there are areas that need improvement, but as far as I could determine from my visits with individual committee members and from the group "Exit Meeting," conducted by the Southern Association Committee with our Administrative Staff at the conclusion of the visit, most of these have been identified through our self-study endeavors. This is highly significant since, in effect, we had specified, prior to the committee's visit, most of the problem areas needing attention.

It is expected that the written report from the S.A.C.S. will be received in about two or three weeks thereby permitting us to meet with the Southern Association Membership Committee on October 27 and 28 in Atlanta, Georgia. If the paperwork is not finished in time for this meeting, our interview with the Membership Committee will take place on December 9 at the Annual Southern Association Meeting in Dallas. Regardless of when the interview with the Membership Committee is scheduled, official action will be announced at a session of the College Delegate Assembly at about 10 a.m. on December 11 during our annual Association Meeting.
