Again as I stated in my letter our Board of Directors, Mr. John Noble, Chairman, (not Board of Regents) do not allow recruitment of this kind.

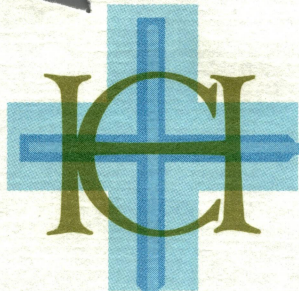
Tyler State College/Texas Eastern University is a two year senior college in Tyler and do offer a Bachelor of Science Degree in Nursing.
