BUDGET RECEIVES TENTATIVE APPROVAL

A \$6,505,744 budget for the 1977 fiscal year was given tentative approval by the TEU Board of Regents at a June 2 meeting. The regents are to meet again at 3 p.m. Monday, June 14, to consider final adoption of the budget. Also to be considered at the June 14 meeting is the 1977-79 Biennial Appropriations Request.

The proposed budget provides \$4,335,262 for educational and general use purposes. This is an increase of \$748,083 from the 1975-76 fiscal year.

Other provisions include \$11,064 for restricted funds, \$270,935 for auxiliary enterprises, \$1,750,000 for plant expansion and \$138,483 for debt service.

In other board action, a gift from Miss Mettie Azalee Rodgers of Tyler of stock valued at between \$5000 and \$5500 to the university was announced by Dr. James H. Stewart, Jr. Receipts from the sale of this stock will provide the furnishings for the reception room on the third floor of the Administration/General Classroom Building.

Faculty and staff listed in the 1976-77 budget were approved for re-appointment.

SUMMER I ENROLLMENT TOTALS 832

The official headcount enrollment for the first summer semester 1976 is 832. This represents an increase of 11 percent over the same period one year ago.

The average student load is 4.92 with 4,097 semester credit hours generated, according to figures available Friday through the office of Admissions and Records.

Previous enrollment figures for Summer I are: 150 in 1973, 526 in 1974 and 750 in 1975.
