7. Faculty Academic Workload Report for the 1977-78 Academic Year

REPORT: In accordance with Section 51.402 (c) of H.B. 1012 enacted by the 65th Texas Legislature, which specifies that within 30 days of the end of each academic year a report shall be filed with the governing board pursuant to the workload of faculty members, this information was provided to the Board of Regents through Administrative Notes for June 5, 1978 and is mentioned herein for the purpose of making this material a part of the official record of the university as an attachment to the minutes of this meeting.

This law requires that the report indicate the department to which each faculty member is assigned along with the academic duties and services performed by each member of the faculty during the nine-month academic year. Moreover, the law requires that the report of academic duties and services performed by each member of the faculty indicate all appointments held by the faculty member within the institution, the salary paid to each appointment and the source of funds from which salary payments were made with all elements of the report relating to requirements established by the governing board.
