1. 1979-80 University Catalog

REPORT: As you will recall, the 1979-80 Texas Eastern University Catalog was sent to each member of the board on April 9, 1979. We are pleased with the seventh edition of the catalog, which I remind you must be submitted to the printer in December in order to make it available for use several months prior to the beginning of the academic year. Perhaps I should point out that if the University of Texas System transfer occurs, it will be necessary to make required adjustments which can be made appropriately. In regard to the production of the catalog, I am especially appreciative to Mr. J. Archie Whitfield for the excellent work performed in coordinating publication of the university document which will provide official information for students and others during the period beginning with the Fall Semester 1979 through the Summer Terms 1980. 3. Faculty Workload Reports

REPORT: Legislation enacted during the 65th Texas Legislature requires that faculty workload reports be submitted to the governing board of each Texas general academic institution according to an established timetable. The Coordinating Board, Texas College and University System was charged by the legislature to develop a standardized report form for use by all institutions. As you are aware, it has been administrative practice within the Texas Eastern University organization for the Board of Regents to regularly be provided this information on a routine basis. The new report form has been developed by the Coordinating Board and copies of the TEU Faculty Workload Reports for the Fall Semester 1978 and Spring Semester 1979 were furnished to you with Administrative Notes for May 7, 1979. The reports are mentioned at this time in order to make the material a part of the official record of the university as an attachment to the minutes of this meeting.

Gifts Presented to Texas Eastern University

Two new scholarships and one scholarship contribution have been presented recently to the university. These include:

Physical Education Scholarship

A \$200 scholarship has been established for graduate students working toward a Master of Art or Master of Education Degree in Health and Physical Education. The initial award will be made for the Fall Semester 1979.

Speech Communication Scholarship

Mr. and Mrs. H. L. Long of Kilgore, Texas have established the Speech Communication Scholarship in honor of Dr. Judy B. Freeman, associate professor of speech. This annual award of \$500 will be made initially in the Fall Semester 1979 to a student working toward a Bachelor of Arts or Bachelor of Science in Speech.

American Association of University Women Graduate Scholarship

A contribution of \$850 has been received from the American Association of University Women, Tyler Branch, toward the scholarship endowment fund goal of \$5,000 which will provide an annual scholarship of \$250 for a full-time graduate student at Texas Eastern University. This permanent scholarship fund was established January 12, 1978, and the first award was made during the Spring Semester 1979. Currently the fund totals \$4,350.
