# President Hamm Speaks On Participation, Trust

Participation and trust were key words in the opening assembly address by George F. Hamm to employees of The University of Texas at Tyler.

"Participation suggests an openness. One which encourages involvement, encourages faculty members and students to inspect, to object, to influence, to become fully cognizant of the process which markedly effects their professional lives,' he said.

In speaking of trust, he said that trust begins with "a confidence in oneself and with a respect for the feelings and judgement of others. In practical terms, it means decision making responsibility should be deligated to the lowest possible level."

The president mentioned some priorities for the university – increasing enrollment, improving salaries for both faculty and staff, developing a student housing program and establishing a sense of community. He said he had listed 24 other such concerns, "each of which I hope can be addressed by you and me at an early date."

#### **BOARD OF REGENTS TO MEET HERE**

The University of Texas System Board of Regents will meet on the UT Tyler campus in October. The board meeting is scheduled for Oct. 8-9. It will be the first visit to the campus for the full board since the university joined the UT System in 1979.

## **Hewett Selected As Dean**

Wendell C. Hewett, a five-year faculty member with The University of Texas at Tyler, has been selected as the new dean for the School of Business Administration. He succeeds George Joyce who asked to be reassigned to a full-time teaching position.

Hewett joined the faculty in 1976 from the University of Alabama. He was named chairman of the Department of Marketing and Management in 1978. He holds the B.B.A., M.B.A. and D.B.A. degrees from Texas Tech University.

The announcement of Hewett as the new dean followed a nation-wide search to fill the post.

"It is a pleasure to announce the selection of Dr. Hewett to this very important administrative and teaching position within the university," George F Hamm said in making the announcement. "It is encouraging that an individual of his caliber is already on the faculty at UT Tyler. We look for outstanding leadership from him in the continued growth of the School of Business Administration."

### Forum Officers Named For 1981-82

Linda Reeves will serve as president of the Eight to Five Forum, an organization of classified employees of The University of Texas at Tyler, for the 1981-82 academic year.

Other officers will include Mary Elizabeth Dorsey as vice president, Barbara McClellan as secretary, Lynne Reynolds as treasurer, Peggy Jackson as historian and Sophia Lenderman as publicity chairman.

Committee appointments include Carol Ashcraft and Lenderman to the Sunshine Committee and Melva Grissom and Julie Davis to the Hostess Committee.

The first meeting of the 1981-82 academic year will be held in UC 134 on Friday, Sept. 4. Installation of officers will be held following the luncheon. The menu will consist of finger foods, punch and desserts. All classified employees are invited to attend.

# UT Tyler Budget Approved

A \$6,449,165 budget for 1981-82 for The University of Texas at Tyler received approval of the UT System board of regents at their August 14 meeting in Austin.

Of the \$6.4 million, UT Tyler's operating budget of almost \$5.6 million shows an increase of 4.6 percent. It includes \$2,265,053 for faculty salaries (up 12 percent), \$500,029 for departmental operating expenses (up 42.6 percent), \$462,509 for library (up 7.1 percent), \$154,960 for staff benefits (up 2.6 percent) and \$17,319 for organized research (up 14.9 percent).

The budget includes \$10,000 for undergraduate scholarships (up 300 percent). Expenditures for physical plant operation and utilities exceed \$1.3 million.

Decreases are shown in six categories —general administration and student services (down 18.6 percent), general institutional expense (down 18.9 percent), instructional administration (down 12.6 percent), campus security (down 3.7 percent), grounds maintenance (down 2.5 percent) and purchased utilities (down 32.8 percent).

In other action, the board approved contracts, amendments to the 1980-81 operating budget, a dental insurance and health care insurance and a request to approve transfer of funds between legislative appropriation items during the 1982-83 biennium.

### **Insurance Rates Established**

Employees in The University of Texas System can pay from \$27.57 to \$169.32 for health insurance in 1981-82 under the plan adopted August 14. The low figure is for individual coverage only under plan 4 UT while the high is for full family under plan 1 UT. Increases in rates range from 4.1 percent under 4 UT to 28.8 percent under 2 UT.

Features common to all plans include: no deductible for bed patient hospital expense, all usual hospital services and semiprivate rooms; psychiatric bed patient hospital annual limit of 120 days; other medical expenses 80 percent; other medical expense psychiatric annual limit of \$1,000; and lifetime maximum of \$1 million.

#### Legislature Approves Increases

Increases in salaries, insurance premium sharing and mileage reimbursement are among changes made by the 67th Texas Legislature which will take effect on Sept. 1.

Classified employees were mandated salary increases of 9.2 percent. An additional 8.7 percent raise is mandated for the second year of the biennium.

Faculty salary increases are not mandated, but considered as merit increases.

The state increased the amount it will provide for premium sharing on insurance to \$48 per month. The share will increase again Sept. 1, 1982 to \$58 per month.

Travel mileage reimbursement goes to 23 cents per mile, up from 20 cents. The basic per diem payment for travel remains at \$40 with a provision that increases the figure to \$45 for lodging and \$15 for meals, based on actual expense, in cities where lower cost housing and food is not available.

The resignation and request for reassignment of Frank H. Smyrl from dean of the School of Liberal Arts to a fulltime position as a professor of history was announced Tuesday by Donald W. Whisenhunt.

Lannom Smith was named interim dean by Whisenhunt for the 1981-82 academic year. Smith has also announced the selection of Janice D. Glascock as interim chairperson of the Department of Humanities and Communication for the same period.

The three changes are effective immediately.

"Dr. Smyrl has served this university faithfully since 1973 and as a dean since 1974. I certainly respect his personal decision to return to the classroom and know he will continue to exhibit his dedication to UT Tyler in the years ahead," Whisenhunt said in making the announcement.

Smith has served as a member of the faculty since 1973 and Glascock joined the faculty in 1975.

#### NEW LIBRARY HOURS ANNOUNCED

New library hours for the fall semester have been announced by Mrs. Olene Harned. The new hours became effective Wednesday. The library will be open from 7:30 a.m. - 9:30 p.m. Monday through Thursday, 7:30 a.m. - 5 p.m. on Friday, 10 a.m. - 2 p.m. on Saturday and 2 - 6 p.m. on Sunday.

### **Dependent Dental Insurance Optional**

Dental insurance coverage will be required of all employees in The University of Texas System who enroll in the health insurance plan. Coverage for dependents will be optional under the dental plan adopted August 14 by the board of regents and effective Sept. 1.

Employee coverage will cost \$6.11. Dependent dental coverage (with employee rate included) is \$15.24 for children, \$11.46 for the spouse, and \$20.59 for family.

Under the plan, the deductible is \$25 per individual with a \$75 maximum for the family each year. Yearly maximum payable per individual is \$1,000.

Coverage is 80 percent on normal dental care costs such as oral exam and teeth cleaning, the treatment of gums, the treatment of the dental pulp and anesthesia. For major dental work (crowns, inlays, onlays, dentures and orthodontics), the insurance company will pay 50 percent of the costs. A \$500 lifetime maximum is listed on orthodontic work.

A dependent enrolled under the dental plan can only be dropped if all coverage — dental and health insurance — is dropped.

Aetna Life and Casualty Company is the carrier for the dental insurance while Blue Cross and Blue Shield of Texas remains the health insurance carrier.
