Search Committee Named; First Meeting Scheduled

The Advisory Committee to recommend nominees for the presidency of The University of Texas at Tyler will meet at 2:30 p.m. Friday, March 20, on the UT Tyler campus for an organizational meeting. The session will be held in UC 134.

Tyler representatives on the committee were announced Tuesday by Chancellor E.D. Walker, who is to serve as chairman for the 17-member group.

Representing the UT Tyler faculty will be Stephen E. Daniels, Wendell C. Hewett, Don W. Killebrew, F. Lannom Smith and Thomas A. Keagy, Robert L. Cox is the elected member of the Dean's Council on the committee.

Two students, selected by the Student Association, to serve on the Advisory Committee are Charles T. Dickson, a junior biology major from Jacksonville, and Allan R. Warren, a senior secondary education major from Tyler.

Rounding out the Tyler representation is Charles L. Childers, president of Tyler Bank and Trust Company and chairman of the UT Tyler Development Board. He was selected by James H. Stewart, Jr.

Members previously appointed by Board of Regents Chairman James L. Powell include Mrs. Jane Weinert Blumberg of Seguin, Tom B. Rhodes of Dallas and Howard N. Richards of Austin, all representing the board; and Wendell H. Nedderman of UT Arlington, Bryce Jordan of UT Dallas and V.R. Cardozier of UT Permian Basin. Representing the UT System will be Ernest T. Smerdon, vice chancellor for academic affairs.

Regents Propose Change

The Board of Regents of The University of Texas System is seeking a constitutional amendment to change the coverage of the Permanent University Fund and the Available University Fund.

The proposed amendment is;

(1) To include all of the institutions which presently comprise the System in the Permanent University Fund Bond Construction Program.

(2) To increase the bond ceiling on Permanent University Fund Bonds from 20 percent to 30 percent of the Permanent University Fund.

(3) To expand the purposes for which the Permanent University Fund bond proceeds may be spent to include:

(A) Acquisition of land with or without new permanent improvements; (B) Construction and equipping of new permanent improvements; (C) Major repair and rehabilitation of permanent improvements; (D) Acquisition of library books and materials; (E) Acquisition of capital equipment; and (F) Approval for refunding of previously issued Permanent University Fund Bonds.

(4) To prohibit the future appropriation of general revenue, not only for new construction, but also for major repairs and rehabilitation at the System institutions.

The UT System Board of Regents continues to support the constitutional principle that the UT share of the Available Fund not needed for debt service be used for academic enrichment at The University of Texas at Austin.

These recommendations nearly double the number of University of Texas components to be served by the PUF bonds.

Childers Heads Development Board

Charles L. Childers, president of the Tyler Bank and Trust Company, was elected chairman of the newly formed Development Board for The University of Texas at Tyler at a Feb. 24 meeting.

Serving as vice chairman of the 15-member board is C. Quentin Abernathy of Gladewater.

At the organizational meeting, the board discussed needs of the university and proposed projects for the office of development.

In addition to the two officers, other development board members include Jeff Austin Jr. of Jacksonville, Bill G. Hartley, J.S. Hudnall, Robert J. Phillips, Jim M. Vaughn, Royce E. Wisenbaker, A.W. Riter Jr., Isadore Roosth, Earl L. Story Jr., Henry M. Bell Jr., Allen M. Burt and George W. Pirtle of Tyler, and B. H. McVicker of Lufkin.
