System Issues Patent Statement

A statement on "Patents and The University of Texas System" has been prepared by Kathy Chapman of the UT System Office of General Counsel outlining the System's policies and procedures for filing for patents.

In the statement, she says one can both publish and patent, one can patent inventions arising from federally-sponsored research, the time required in filing a patent is much shorter than most anticipate and the UT System has a patent policy which applies to all employees.

Currently the System has 55 patents pending.

A patent is a grant by the U.S. Patent and Trademark Office to an inventor or his assignee (the inventor's employer) of the right to exclude others for 17 years from practicing the invention except for experimental purposes.

Copies of Ms. Chapman's statement are available in the Public Information Office and may be examined at any time.
