UT Tyler to award 197 degrees Aug. 3

The University of Texas at Tyler will award degrees to 197 summer graduates at the 1984 summer commencement, scheduled for 7:30 p.m. Friday, Aug. 3 in the University Center. UT Tyler president George F. Hamm, will address the graduating class.

Included in this year's summer commencement are 85 students receiving master's degrees and 112 baccalaureate recipients. The first master's degrees in Planning and Public Administration and Computer Science will be awarded during the commencement program.

Conferral of degrees will be by President Hamm, with presentation of the degree candidates being made by Dr. Thomas A. Keagy, assistant to the president for academic affairs, Dr. George Joyce, senior faculty member, School of Business Administration, Dr. Robert L. Cox, dean of the School of Education and Psychology, Dr. Lannom Smith, dean of the School of Liberal Arts, and Dr. L. Lynn Sherrod, dean of the School of Sciences and Mathematics.

The Rev. Ronald M. Guinn, pastor of the Highland Presbyterian Church, will give the invocation and the Rev. Dan B. Bynum, minister of Glenwood United Methodist Church of Tyler will give the benediction.

Alumni Association president Robert Turner will represent the UT Tyler Alumni Association. Dr. Kenneth Muckelroy, chairman of the Department of Music, Steve Satterwhite, tenor, and Vicki Conway, pianist, will present the musical portions of the program. Dr. Frank H. Smyrl, senior faculty member, will serve as macebearer.

A reception will be held on the second floor of the University Center following the commencement program.

"UT Tyler Rose" bushes planted on campus

A new rose has been patented and registered under the name "UT Tyler Rose." The first 30 bushes have been planted in two beds on either side of the Old Omen Road entrance to the campus.

Developed by Dr. E.W. Lyle, there are some 1,000 bushes being grown in a local nursery.

The bush, which is expected to grow between four and six feet tall, will bear medium-sized orange buds.

Additional "UT Tyler Rose" bushes will be planted throughout the campus as they mature. Also, plans are being made to present the City of Tyler with enough bushes for a bed at the Rose Garden.

New M.A. degrees approved by Coordinating Board

The University of Texas at Tyler has been authorized to award Master of Arts degrees in both English and history this fall by action taken by the Coordinating Board, Texas College and University System, at its quarterly meeting in Austin August 20.

The addition of these degree programs permits UT Tyler to respond to growing public demand of teachers and other prospective students in the East Texas area. The two liberal arts programs join the 21 graduate degrees currently offered by the university.

"These actions reflect a serious commitment by the Coordinating Board to the academic integrity of UT Tyler and to the development of the intellectual resources of the entire region," said Dr. George F. Hamm.

Students enrolled in these 36-hour programs will have the opportunity to select either a thesis or non-thesis track of study.

Purchasing Dept. defines small and minority owned businesses

Each year the Purchasing Department must report to the Governor's Office the names and dollar amount of purchases from small and minority owned businesses. This is mandated per letter, dated May 10, 1984, from Governor Mark White to President Hamm.

In order for this report to be complete, this information must be included on the purchase orders issued by the various departments. Therefore, when placing a purchase order, determine if the company qualifies as a small business and/or a minority owned business. If the vendor does not know if the company qualifies as either or both of these, give him the definition as given below:

A company qualifying as a small business either has less than 100 employees or they gross less than \$1,000,000 a year.

A company qualifying as a minority business is any business owned by a minority person (woman, hispanic, black, etc.).

If the company qualifies as either, note the information on the face of the departmental requisition. Examples: Small Business or Minority Business or Small and Minority Business
