# Fall enrollment sets state pace

The University of Texas at Tyler has reached a record enrollment of 3,634 for the fall semester.

"UT Tyler is one of the few universities in the state of Texas to have an increase this semester," Martha Wheat, director of admissions, said. Room capacity caused the closing of 26.6 percent of classes within the School of Business Administration, as well as an additional 24 classes across campus.

"We had a lot of good comments on the installment plan for tuition payment. Students really appreciated it," Wheat said. Increased tuition, particularly out-of-state tuition, along with limited faculty and space kept enrollment figures at UT Tyler from going even higher, she added.

Enrollment for the 1984 fall semester was 3,551.

#### CHANGE IN NEPOTISM STATUTE

Senate Bill 599 amends the existing nepotism statute and provides that it shall not prohibit continued employment of individuals who otherwise would be affected because of a family relation to a superior *if* those individuals were employed at least one year before the superior with whom they are related was appointed (presently there is a two-year requirement).

When these individuals are permitted to keep their jobs because of the above exemption from the nepotism statute, their superior may not exercise control over decisions affecting their basic personnel-related policies.
