U.S. attorney to speak at commencement

The Honorable Rudolph Giuliani, U.S. attorney for the southern district of New York, will be the speaker for The University of Texas at Tyler spring commencement Friday, May 8. A total of 312 degree candidates -- 261 at the bachelor's level and 51 at the master's level -- are to be recognized in the ceremony which begins at 7:30 p.m. in Harvey Hall.

Giuliani has received national recognition for his efforts in prosecuting cases involving New York mafia families, as well as for his role as a prosecutor in police corruption and bribery trials.

President George F. Hamm will provide the welcome and introductions, and certification of degree candidates. Dr. James P. Duncan, UT System executive vice chancellor for academic affairs, will confer degrees. Presentation of degree candidates will be by Dr. Thomas L. Fernandez, vice president for academic affairs, and representatives of each school: Dr. Robert T. Partain, School of Business Administration dean; Dr. Robert L. Cox, School of Education and Psychology dean; Dr. F. Lannom Smith, School of Liberal Arts dean and Dr. Robert H. Cranford, Department of Mathematics chairperson. Macebearer will be Dr. Frank H. Smyrl, senior faculty member.

Deadlines announced by Purchasing Office

Requisition deadlines for the end of the 1987 fiscal year have been set by the Office of Financial Services. Purchasing deadlines are:

Open Market Requisitions: June 12. Any requisitions for open market orders received after that date will be charged to FY 88 funds. Effective immediately and until the end of the current fiscal year, any requisition intended to be charged to FY 87 funds should be clearly marked in red. Note: Computer related classes and telephone services have a required submission date of May 15, 1987.

Rental orders: June 12, or as soon as possible thereafter, so they can be processed through the State Purchasing and General Services Commission prior to the beginning of the next fiscal period. These are not automatically renewed at end of each fiscal year.

Contract and Spot Purchase Requisitions: Aug. 7. Any contract and spot purchase requisitions received after that date will be charged to FY 87 funds.

Maintenance agreements: June 12. Must be renewed on an annual basis. Submit each maintenance agreement request separately on a departmental purchase requisition.

Any order placed from FY 87 funds for consumable items should be submitted early enough for the goods to be received by Aug. 28. Requisitions submitted after the above cutoff dates will be assigned a FY 88 purchase order number and paid for from FY 88 funds.
