# Guest lectures to be presented

Relationships and biomechanics are topics to be presented this week by distinguished guest lecturers in the Summer Scholars Program.

Dr. Alan Rosenbaum, recipient of several federal grants dealing with family violence and marital relations, will discuss "Aggressiveness in Dating and Marital Relationships" at 7:30 p.m. Tuesday, July 19 in the UC Open Area.

Dr. Richard C. Nelson, advisor on biomechanics for the Medical Commission to the International Olympic Committee (IOC), will speak on "Biomechanics at Penn State, the Olympic Games and the Courtroom," 7 p.m. Wednesday, July 20 in ADM 127, and "The Role of Biomechanics in the IOC Medical Commission," 7:30 p.m. Thursday, July 21 in the UC Open Area.

Rosenbaum, an associate professor in the Department of Psychiatry at the University of Massachussetts Medical School, serves as a member of the editorial board of *Journal of Family Violence* and is guest consulting editor to several other professional journals.

Nelson, director of the Biomechanics Laboratory at Pennsylvania State University, has been a visiting professor at universities in Switzerland, West Germany, Japan and the Republic of China as well as the United States.

Carolyn Corbin, author and president of an international consulting firm, will present "Strategies 2000" in the UT Tyler Management Speaker Series 9 a.m. - noon Thursday, Aug. 4 in BUS 158.

Corbin's book *Strategies 2000*, originally researched for IBM, is being used in major corporations and university management courses nationwide. Central Stores: The bookstore will continue to handle many of the items used by various offices and will provide a charge system for M&O accounts. The following items may be acquired through the Print Shop or the University Bookstore in order to take advantage of state contract purchasing: thermofax masters, legal pads, copy paper, tape, and computer labels. A list of those items available through the Print Shop and those items available through the bookstore will be made available to university personnel.

The bookstore will continue to provide faculty and staff discounts of 10 percent on all items over \$1, excluding textbooks and several items offered at cost or below.

**Dr. Neil Ford**, associate professor of biology, and Richard Seigel, assistant professor of biology at Southeastern Louisiana University, are recipients of a \$46,830 grant from the Louisiana Education Quality Support Fund for their project, "Phenotypic Variation in Life History Characteristics of Snakes." Ford also presented an invited paper, "Snake Avoidance of Odors from Ophiophagous Snakes," in the Reptile Chemical Ecology symposium at the International Society of Chemical Ecology June 24 in Athens, Ga.
