# United Way campaign extended

UT Tyler's United Way campaign has been extended through Monday, Oct. 31. Contributions received thus far total \$5,300, about \$1,000 short of the \$6,395 campaign goal.

Employees who wish to increase their pledge may do so simply by calling the Public Information Office; the new amount will be entered on the pledge card already submitted.

Employees who previously indicated no contribution may request a new pledge card from the Public Information Office on which to enter the amount they now wish to donate.

University employees who still have their pledge cards and have not yet contributed are urged to submit their pledge card to the Public Information Office.

Participants may pay the full amount of their pledge or any portion with return of the pledge card, or may choose to be billed by the United Way office (payroll deduction is not available at UT Tyler).

Twenty-three agencies are served by United Way of Greater Tyler, providing information and referral services, help for the mentally and physically disabled, family and individual counseling, day care, character building, disaster assistance and senior citizens services.

# **Drawings exhibition opens**

Drawings by Gary Frields and Frank Herbert, artists currently teaching in the East Texas area, will be on exhibit Oct. 10 - Nov. 4. The exhibit will be open to the public free of charge 8 a.m. - 5 p.m. weekdays in UC 101.

Frields is assistant professor of art at Stephen F. Austin State University and co-director of the Griffith Gallery. Herbert is acting chairman of the Department of Art at Kilgore College.

Frields holds M.A. and M.F.A. degrees in drawing and sculpture from SFASU and a B.F.A. in commercial design from Baylor University. He previously served as Department of Art chairman at Kilgore College and as gallery assistant at Riverside Art Center and Museum in Riverside, Calif. Exhibitions in which his works have won awards include the "All Texas 2D Competition/Exhibition," Texas A&M University; "New Figurative Drawing in Texas," San Antonio Art Institute; and the "13th Annual National Drawing and Sculpture Show," Del Mar College, Corpus Christi.

Herbert received an M.F.A. in drawing from Colorado State University and a B.F.A. in studio art, cum laude, from Louisiana Tech University where he also earned a post-graduate scholarship to study in Rome, Italy. He also has taught at Colorado State and has exhibited work at the Stoner Arts Center, Shreveport, La.; Longview Museum and Arts Center; Lamar University, Beaumont; Southwestern University, Georgetown; the Arkansas Arts Center, Little Rock, Ark; and the Reasor Gallery, Spokane, Wa.
