"This is not your typical vintage Neil Simon comedy," says Janee McGoff, instructor of drama and director of the production.

Simon, author of such hits as "The Odd Couple" and "Barefoot in the Park," described the play as "too funny to be drama, too dramatic to be comedy." The story focuses on Evy, an alcoholic who returns home after six months in a sanitarium, her alcoholism's effect on her daughter, and the flawed friends with whom she surrounds herself.

Shelly Stevens stars as Evy and Madeline Wilson plays her daughter Polly. Completing the cast are D. M. Phillips as Toby; Jere Hunter as Lou; Carl Millegan as Manuel; and Roy Larson as Jimmy.
